- 6. **Craobh Rince Céilí** Céilí teams must dance Part B only of any Eight Hand dance from Ár Rince Céilí, with the exception of the U10 céilí team who will dance Part A.
- 7. **Rincí Foirne** For Cor Ceathrar tops only will dance the first figure.
- 8. All 2 and 3 hand competitions will dance <u>32 bars</u> only.
- 9. Preliminary competitions results will be taken from the first two rounds in all age groups from 8 9 up to 17 18 inclusive. Teachers MUST tick the appropriate box on the entries to ensure that competitors are registered in the Preliminary competitions.
- 10. **Preliminary Grade Rules/Eligibility:** A dancer who meets the following criteria is eligible to enter the Prelim competition at Oireachtas Chonnacht 2017:-
  - Preliminary Championships (8-9 years upwards) are confined to competitors who have not been placed in the top 5 in an Open Championship judged by 3 or more adjudicators.
  - The dancer must not have qualified for the Worlds in 2017 or 2018 (with the exception of the boys who are eligible if they qualified but were not placed in the top 3 at their Regional Oireachtas and who otherwise fulfil the Prelim criteria).
  - Dancer must have not recalled in the actual Championship at the All-Ireland 2016 or 2017.
  - Competitors must not have won a Preliminary Championship more than two times in the current year.
  - If the dancer has not succeeded in placing in the top 5 but has won two Preliminary Championships in the current year, they are eligible to dance preliminary again the following year.

- 11. **Birth Certificates** The correct date of birth must be completed on entry. Birth certificates must accompany entries from competitors who have not previously submitted a birth cert. Short form birth certificate will suffice. No photocopies or baptismal certificates will be accepted.
- 12. **Dancing Costumes** Please inform your pupils that full costume including socks and shoes must be worn on stage for all presentations. Failure to do so will result in the dancer or team being excluded from presentations.
- 13. **Teachers** must produce ID badges to gain free admission to the venue.
- 14. **Running Order of Dances** Under 7, 7 8 and 8 9's will dance the Reel first. All other age groups will dance the heavy round first.

### Entries on line to FEISENTRY.COM

Entries will be accepted only from teachers registered with An Coimisiún le Rincí Gaelacha.

Entries are to be accompanied by ONE CHEQUE ONLY and for the full fee due.

Cheques should be made payable to "Connacht Regional Council".

NO POSTAL ORDERS or CASH will be accepted.

No entries will be refunded.

**FAMILY FEE:** 200 euro. Teachers may apply to Comhairle Chonnacht for the family fee, listing all the names of competitors and the competitions they are entering. Only immediate family may be included, i.e. siblings.

### Rules of the Oireachtas

- 1. Comhairle Chonnacht is **NOT** responsible for loss or damage to personal property.
- 2. Objections, if any, should be made in writing to the Secretary and accompanied by a fee of 30 euro. Objections must be lodged prior to the result and will be dealt with after the Oireachtas. No meetings will take place during the Oireachtas.
- 3. The Comhairle will, as far as is practicable, provide stage surface suitable for dancing. However the comhairle cannot accept any liability for injuries sustained while on stage. The lodgement of an entry will be deemed to be an acceptance of this provision by a dancer.
- 4. Dress code in accordance with An Coimisiún ruling will be observed. Dancers will not be permitted to walk around in their underwear.
- 5. Health & Safety: In the interests of children's health, hairspray or any form of sprays are not allowed to be used in the hall at any time; before, during or after competitions.
- 6. Only competitors, Comhairle members and teachers will be allowed side-stage.
- 7. Photography: As per An Coimisiún rules, "The use of any form of unauthorized photography which has the capability of capturing a dancer's image while in motion is strictly forbidden". Any person found in breach of this rule will be asked to leave the championships.
- 8. Make Up: as per An Coimisiun ruling, make-up including false eye lashes is not permitted on any dancer under the age of 10 years.
- 9. Cups & Tiaras: All perpetual trophies/cups/tiaras awarded in 2014 must be returned to Comhairle Chonnacht on the stipulated date in good condition. Solo or Team competitors failing to comply with this rule will be refused the right to compete at this year's Oireachtas until a fine of 200 euro is received by the Comhairle. The holder and his/her parents shall be responsible for any loss or damage to a trophy/cup while in the holder's possession. The holder's teacher shall be responsible for ensuring that the trophy/cup is returned in good time and in good condition.

#### CLRG MEDIA POLICY - Oireachtas Rince Chonnacht

Any form of unauthorised photography which has the capability to capture a dancer's image whilst in motion, using electronic or manual means e.g. mobile phone, standard camera, video camcorder, commercial film, with or without enhancement, is expressly forbidden.

Comhairle Connacht has appointed an official photographer for Oireachtas Rince Chonnacht, who will take photographs and videos of competitors, competitions and presentations. Such photographs and videos may be subsequently used for the marketing and promotional purposes of the organisation including the publication of such photographs on the official website <a href="www.connacht.ie">www.connacht.ie</a> and CLRG social media outlets.

Comhairle Connacht may also appoint other agents during the course of the Championships for special promotional projects and reserves the right to permit suitably accredited photojournalists to take photographs on a case by case basis. Should any dancer or dancer's parent or guardian wish to be excluded from any of these photographs, please contact any member of the Oireachtas Committee with relevant details.

**PLEASE NOTE:** Other than the photographs taken by the official photographer, authorised agents of **Comhairle Connacht** or accredited photo journalists, all photographs captured at the event including images of competitors and presentations may only be taken for **personal use**. They may not be redistributed, sold, lent or passed on to third parties. They may also not be used for commercial purposes or used in any publication or posted to any website without the express written permission of **Comhairle Connacht** and the parents or guardians of all dancers included in any particular picture.

**PROFESSIONAL PHOTOGRAPHY EQUIPMENT** will not be permitted inside the competition rooms with the exception of individuals that have a valid CLRG photo pass. Attendees are not allowed to bring zoom lenses greater than 70mm inside the dance events, and no individuals will be granted access to take photographs on or near the stage during the competitions.

**MEDIA APPLICATIONS:** Accredited journalists may apply for event access and photo passes by contacting **Comhairle Connacht** All applicants will be required to complete the necessary paperwork and be compliant with our child protection policy and all rules of **Comhairle Connacht and of CLRG**.
