Saturday 24th October: Under 12- Senior Championships Sunday 25th October: Under 6-Under 11 Championships plus Meangrad Championships (These days are provisional, and times will only be allocated when all entries are finalized)

Awards

Top 5 in Open, Prelim & Meangrad Championships will receive Trophies & Sashes. Everyone will receive a Championship Medal and 2 Solo Medals in their entry pack.

Entrance Fee

This is included in your entry (strictly only one person per entry can gain access to the halls, i.e. Parent, guardian or teacher)

Championships

All Championships be will be adjudicated by 3 Adjudicators.

Entry Process

Entry Information

Entries can be made either by parents or teachers (not both), and this will be on a first come first served basis. All Information must completed for each dancer.

There will be two halls running each day, and these will be treated as two separate competition halls; (there will be strictly no mixing of halls).

In the case that one age group is over the capacity, it may be a split into either separate Prelim and Open OR combined competitions of A & B. For example, U12A in one hall & U12B in the other hall, split alphabetically and evenly with prelim & open dancers. Two Separate open & prelim results will then be given.

Our Cap in each competition is 30 dancers. There will be a recall of 50%.

We will post on social media "Carson Kennedy Irish Dance" when our entries have been capped.

Entries Open: Tuesday 15th September (9am)

Entries Close: When our cap is filled.

Successful entrants will be emailed with payment information. Failure to make payment within any assigned timeframe will void any entry. This spot will then pass to the next dancer on the waiting list.

Fees are non-refundable unless the event does not go ahead.

Entries received before the opening time or without complete information, will be null and void and will not be accepted.

Feis Running & Safety Rules

Covid-19 Feis Guidelines

The below guidelines are complying with the NI Stormont Executive, the Public Health Agency of Northern Ireland and the Crowne Plaza Hotel

- No one will gain entry to the area of the feis until your allocated time.
- There will be 2 separate social distanced Holding areas and allocated times for each age group will be on the timetable.
- Temperature checks will be undertaken before you gain entry into your holding area. If your temperature is above 38 degrees Celsius, you will not be permitted into this area or the Halls.
- When entering the holding area, you will need to have a waiver prefilled out which will be collected by a member of staff, (anyone that does not have this filled out will not gain entry).
- The holding area is where dancers will collect their dancers' packs. These areas are also were dancers will get dressed and ready to enter the designated hall. You will then be escorted to your dance hall ready to compete.
- Sanitizer stations upon entry, in hall & when exiting. Please ensure you sanitize your hands often. This will be provided by the venue.
- Separate Entry & Exits for each hall.
- Masks must be worn by all attendees as soon as you enter the hotel, except dancers when they are performing. (anyone that has medical reasons for not wearing must show exemption at entrance)
- One Adult only per entry, i.e. parent, guardian or teacher, each attendee will be given a colour-coded wristband.
- An entry pack will include; Number, Sanitised Pin, Wristband & Medals for solo rounds and championship.
- Chairs will be set out to adhere to social distancing in pods of 2 and cannot be moved. (no mixing of pods)
- Dancers when lining up will be brought up in groups of 8. The dancers will dance in 2's, the music will continually play for each group of 8. When you have finished you bow and walk off and the next two will walk on ready to dance. There will be a music break after each group of 8.
- If a dancer falls or is sick, the adult with them will have to assist them. This is not the stage steward's responsibility.
- There will be COVID-19 guideline posters throughout the building.
- Attendees are encouraged to download Stopcovid NI track and tracing app.
- Feis Helpers will be wearing masks throughout the venue.
- Results area will be separate and social distancing will apply here.
- When and if a podium is used, there will be distance between each placing.
- Please stay home if you or any of your family are feeling unwell.
- There will be Covid Cleaning in between each group provided by hotel staff.
- Idance Irish Vendor will be operating at the feis.
- Toilets will be cleaned regularly by hotel staff, please adhere to their allowance in a toilet at any one time.
- A Risk assessment has been carried out by the venue and the amount allowed in any one hall or holding area. This has been passed legally and deemed safe under the current guidelines.

If you are sick with a sore throat, high temperature, loss of smell/taste etc please do not attend the feis.



Feis Rules

COMPETITION RULES

- 1. The adjudicator's decision is final.
- 2. Age taken as at 1st January 2020.
- 3. Entries only accepted from teachers registered with An Coimisiún le Rincí Gaelacha.
- 4. No refunds except in the case that the event does not run.
- 5. In Prelim and Open Championships, up to and including under 10, make-up and tan is not permitted.
- 6. To be eligible for the Prelim Championship, dancers must never (a) previously won an open championship judged by 3 or more adjudicators, (b) never previously won more than three preliminary championships judged by 3 or more adjudicators and (c) not have qualified for the World Championships in either the current or previous year.
- 7. No block/en point (stationary or moving) will be allowed for all ages up to and including Under 11.
- 8. Dances permitted in Traditional Set Dance are: St. Patrick's Day, Blackbird, Job of Journey Work, Garden of Daisies, King of the Fairies, Three Sea Captains or Jockey to the Fair.
- 9. Music will be played at the following speeds: Prelim & Open: Reel 113, Single Jig 124, Light Jig 116, Slip Jig 113, Heavy Jig 73, Hornpipe 113. Traditional Set Dances: Blackbird 144, St. Patrick's Day 94, Job of Journeywork 138, Garden of Daises 138, King of the Fairies 130, Three Sea Captains 96, Jockey to The Fair 90.

OTHER RULES

- 10. Any form of unauthorised photography which has the capability to capture a dancer's image whilst in motion, using electronic or manual means e.g. mobile phone, standard camera, video camcorder, with or without flash enhancement, is strictly prohibited. Photography is permitted during results.
- 11. Any parent who would not like their child to appear in photos taken by the feis committee should make the feis organiser aware prior to results being announced.
- 12. Any objections must be lodged in writing within one hour of result, accompanied by fee of £20.00.
- 13. The feis committee will not accept any responsibility for personal injuries or articles lost at the feis.
- 14. The feis committee reserves the right to transfer competitions/results to a different stage or to alternate competitions if it becomes necessary in order to help the feis run smoothly. The committee reserves the right to use a relief adjudicator.
- 15. The feis committee reserve the right to refuse feis entries or entrance into the feis.

I am aware that other persons may attend the feis and may have been exposed to the Covid-19 virus. I am aware of the risks, dangers and hazards associated with attending the feis at this time and I (or on behalf of the participant) freely accept and fully assume all such risks, dangers and hazards and the possibility of personal injury, illness or loss resulting there from. I am aware that I (or on behalf of the participant) may require first aid, which may require 'hands-on' care and social distancing may not be possible in this instance.

WAIVER OF CLAIMS

I agree to waive any and all claims that I now or in the future may have against the feis organisers, any of them directors, employees, contractors, assigns, and/or successors (the "releasees") and to release the releasees from any and all liability for any injury, illness or loss may suffer as a result of attendance at the feis due to Covid-19. I agree the feis organisers have carried out a thorough risk assessment prior to the running of the feis and have put in place all measures to negate any risk of the virus being spread and/or contracted during same.
