COMPETITION RULES

- 1. Adjudicator's decision is final.
- 2. Age taken from 1st January 2021.
- 3. Entries only accepted from teachers registered with An Coimisiun Le Rinci Gaelacha.
- 4. Fees are non-refundable except in the case the Feis doesn't run. 5. In prelim and open championships, up to and including U/10, make - up and tan is not permitted.
- 6. To be eligible for prelim championships, dancers must have never (a) previously won an open championship judged by 3 or more adjudicators (b) never previously won more than three prelim championships judged by 3 or more adjudicators (c)not qualified for World Championships in either this or the previous year.
- 7. No block/en point (stationary or moving) will be allowed for all ages up to and including u/11.
- 8. Dances permitted in traditional set dances are: St Patrick's Day, Blackbird, Job of Journey Work, Garden of Daisies, King of Fairies, Three Sea captains or Jockey to Fair.
- 9. Music will be played at following speeds: (prelim and open:) Reel 113, Single Jig 124, Light Jig 116, Slip Jig 113, Heavy Jig 73, Hornpipe 113. Traditional Set Dances: Blackbird 144, St Patrick's Day 94, Job of Journeywork 138, Garden of Daisies 138, King of the Fairies 130, Three Sea captains 96, Jockey to Fair 90

OTHER RULES

- 10. Any form of unauthorised photography which has the capability to capture a dancer's image whilst in motion, using elec tronical or manual means e.g. mobile phone, standard camera, video camcorder, with or without flash enhancement, is strictly prohibited. Photography is permitted during results.
- 11. Any parent who would not like their child to appear in photos taken by the Feis committee should make the Feis organiser aware prior to results being announced. 12. Any objections must be lodged in writing within one hour of result, accompanied by £20 fee.
- 13. The Feis committee will not accept any responsibility for personal injuries or articles lost at the Feis.
- 14. The Feis committee reserve the right to transfer competitions/results to a different stage or to alternate competitions if it becomes necessary in order to help with the smooth running of the Feis. The committee reserves the right to use a relief adjudicator.
- 15. The Feis committee reserve the right to refuse entries or entrance in to the Feis.

COVID 19 FEIS GUIDELINES

The below guidelines are complying with NI Stormont Executive, the Public Health Agency of Nothern Ireland and the Best western white Horse Hotel

- 1. No one will gain entry to the area of the Feis until your allocated time. 2. There will be a separate social distance holding area and allocated times for each age group which will be on the timetable.
- 3. Temperature checks will be undertaken before you gain entry into your holding area. If your temperature is above 38 degrees Celsius, you will not be permitted into the hall.
- 4. When entering the holding area, you will need to have your waiver prefilled out, which will be collected by a member of
- staff (anyone who that doesn't have this filled out will not gain entry).
 5. The holding area is where dancers will collect their dancers pack. This area is where the dancers will get dressed and ready to enter the main hall. You will be escorted to the main hall when ready to compete.
- 6. Sanitizer stations upon entry, in hall & when exiting. Please ensure you sanitize your hands often. This will be provided by the organisers.

 7. Separate entry and exits into both halls.
- 8. Masks must be worn by all attendees as soon as you enter the hotel, except dancers when they are performing. (anyone with a medical reason for not wearing must show exemption at entrance).
- 9. One adult only per entry, each attendee will be given a colour coded wristband. 10. Entry pack will contain number, sanitised pin, wristband, 2 solo and championship medal.
- 11. Chairs will be set out to adhere to social distancing in pods of 2 and cannot be moved. Dancers will be lining up and will be brought up in groups of 8. The dancers will dance in 2s, the music will continually play for each group of 8. When you have finished, you bow and walk off and the next two dancers will walk on, ready to dance. There will be a break in music after each group of 8.
- 12. If a dancer falls or is sick, the adult with them will have to assist them. This is not the stage steward's responsibility.
- 13. Attendees are encouraged to download STOPCOVID NI track and trace app. 14. Feis helpers will be wearing masks t hroughout the venue.
- 15. Please stay home if you or any of your family are feeling unwell. 16. Toilets will be cleaned regular by hotel staff, please adhere to their allowance in a toilet at any time.
- . 17. A risk assessment has been carried out by the venue and the amount allowed in any one hall or holding area. This has been passed legally and deemed safe under the current guidelines.

I confirm that I (or on behalf of the participant) am in good health and have not travelled internationally in the past 14 days and will inform my teachers, who will inform the feis organisers, should they plan to travel abroad.

ACKNOWLEDEGEGMNT AND VOLUNTARY ASSUMPTION OF RISK

I CONFIRM THAT I AM VOLUNTARILY SIGNING THIS AGREEMENT.

I am aware that other persons may attend the feis and may have been exposed to the Covid-19 virus. I am aware of the risks, dangers and hazards associated with attending the feis at this time and I (or on behalf of the participant) freely accept and fully assume all such risks, dangers and hazards and the possibility of personal injury, illness or loss resulting there from. I am aware that I (or on behalf of the participant) may require first aid, which may require 'hands-on' care and social distancing may not be possible in this instance.

WAIVER OF CLAIMS

I agree to waive any and all claims that I now or in the future may have against the feis organisers, any of their directors, employees, contractors, assigns, and/or successors (the "releasees") and to release the releasees from any and all liability for any injury, illness or loss may suffer as a result of attendance at the feis due to Covid-19. I agree the feis organisers have carried out a thorough risk assessment prior to the running of the feis and have put in place all measures to negate any risk of the virus being spread and/or contracted during same.
