### Preliminary Championship (Girls and Boys): SOFTSHOE ROUND FIRST

Rule regarding preliminary championships in the Mid Atlantic Region states that Preliminary Championships are open to dancers who have won 1st in Prizewinner softshoe (reel or slipjig) and hardsoe (treble jig or hornpipe) dances. Preliminary dancers who win THREE 1st places in one calendar year must advance to Open Championship the next calendar year. Preliminary dancers who win the third 1st place over more than one calendar year must advance to Open Championship the weekend after they earn the third 1st place.
